#### Registration

To register for the tour please fill out the form and **sign all 5 pages**. Please send completed registration to Summit Tai Ji Academy via email or by mail with a full payment amount. If you choose to send your registration and payment separately, the payment must be received within 5 business days from when the registration form arrives. Otherwise, the registration will be considered invalid.

#### Registration Fees

- \$2,200 if registration form and payment are both received by July 15, 2019
- \$2,500 if registration form and payment are both received by August 15, 2019
- \$2,800 if registration form and payment are both received after August 31, 2019

\*\* The registration may be considered invalid if the registration form or payment is not received by September 15, 2019.

\*\* Registration fees include domestic traveling in China, Taijiquan tour activities, 12 nights in hotels and 3 meals/day during the Tour. Please check the details in the Itinerary.

\*\* Registration fees do NOT include international travel, visa applications, insurance, special requests for the tour, or activities outside the tour. Additional tourist activities may be arranged per request and extra fee will apply.

#### Traveling to China (Important Information)

Many nationals including U.S. citizens must obtain a visa prior to arrival in China and passports must have at least six months validity remaining. Be sure to visit the Chinese embassy website for related information. U.S. citizens may visit the U.S. State Department website for the latest travel advisories related to China. As needed, participants must apply for a visa and purchase international plane tickets to Beijing through their travel agents or by themselves. **Summit Tai Ji Academy is not a travel agent**, but offers assistance for applications for China visas and the purchase of international plane tickets through travel agents with an additional fee of \$200 per person. It is highly recommended that participants send visa applications **at LEAST one month** prior to our departure. It is also highly recommended that participants understand the health and vaccination protocols outlined by the Centers for Disease Control and have travel insurance and overseas health insurance.

#### **Cancellation and Refund Policy**

Cancellations must be submitted and dated in writing via Email or by Mail with participant's full name and signature. Refunds are made according to the following schedule:

- If the tour is oversubscribed or canceled by Summit Tai Ji Academy, a full refund will be offered with no fee.
- If cancellation is received by August 31, 2019, a refund of 75% of the full payment will be made.
- If cancellation is received by September 15, 2019, a refund of 50% of the full payment will be made.
- If cancellation is received after September 15, 2019, there will be *no* refund.
- If participant leaves the tour for any reason during the trip, there will be *no* refund.

# TAIJIQUAN TOUR ITINERARY 2019

- Day 1: September 20, Beijing

Upon your arrival, you are guided to the hotel to rest and refresh before dinner. Dinner meeting is arranged from 5:00 pm to 8:00 pm, to include tour introduction, QA and discussion. Taijiquan form review and exercise may be held after dinner depending on the group's interest.

- Day 2: September 21, Beijing

Tour activities include Taijiquan group exercise in the morning and visit to the city according to the group's interest. Group breakfast, lunch, and dinner are arranged

- Day 3 to Day 7: September 22 - September 26, Wudang Mountains

Group leaves in the morning of September 22 for Wudang Mountains. Tour activities include Taijiquan group exercise with Wudang Daoists and /or instructors in Wudang Mountains. The exercise includes Taijiquan forms, weapons and push-hands practice. Group visits the mountains and Daoist temples. Group breakfast, lunch, and dinner are arranged.

- Day 8 to Day 13: September 27 - October 2, Handan and Guangfu

Group leaves in the morning of September 27 for Handan. Tour activities include Taijiquan group exercise with local Taijiquan practitioners, instructors and masters. It includes form reviews and corrections, and push-hands practice. Group breakfast, lunch, and dinner are arranged. Group will visit Grandmaster Yang Lu-Chang and Wu Yu-Xiang's houses.

- Day 14: October 3, Guangfu to Beijing, End of Tour

Last day to practice Taijiquan in the morning at Grandmaster Wu Yu-Xiang's house or the local Buddhist temple. After breakfast, group travels back to Beijing via high-speed-train. End of tour. Participants will be free to depart for your next journey.
